3. Interim Amendment to the 2015 Master Plan for Water & Sewerage

The Department of Public Works has prepared an interim update to the 2015 Water & Sewer Master Plan to incorporate water and sewerage plan updates resulting from County and private development activity. The Department seeks a recommendation of approval from the Board to the County Executive. Updates include descriptions of County legislative activity; entries of properties into the Metropolitan District and Planned Service Area; changes to the service priority categories for individual parcels and lots; and changes to the service priority categories for water and sewer projects proceeding through the County development process.
