Committee

WHEREAS, after his election, Howard County Executive Calvin Ball formed a Transition Team made up of committees of experienced community members to assist and inform his administration's transition into office; and

WHEREAS, members were tasked with making recommendations to County Executive Ball regarding the full scope of county government, divided into ten issue areas; and

WHEREAS, the Transition Team identified current strengths, as well as opportunities for growth and issued its report in January of 2019; and

WHEREAS, the Transition Team suggested the creation of a short-term work committee to further review the Office of Human Rights; and

WHEREAS, The Office of Human Rights is responsible for administering and enforcing provisions of the Howard County Human Rights Law, including, but not limited to:

- (a) Investigating complaints of discrimination to determine whether a violation of the Howard County Human Rights Law has occurred; and
- (b) Attempting to eliminate violations of the Human Rights Law by conference, conciliation and persuasion. Howard County Code Section 12-205; and

WHEREAS, the Transition Team noted that a work committee "should focus on examining the underlying code that governs this area, case sourcing and the investigation process, and make recommendations on how the office can function as a model Civil Rights agency." Transition Team Report at p. 5; and

WHEREAS, the County Executive wishes to follow the direction of the Transition Team and create an "Office of Human Rights Review Committee" (the "Committee").

**NOW, THEREFORE, BE IT ORDERED**, that the Office of Human Rights Review Committee is hereby established.

AND BE IT FURTHER ORDERED, that the following individuals are appointed as members of the Committee:

## AND BE IT FURTHER ORDERED, that the duty of the Committee shall be to:

- (1) Examine County Code provisions that govern the Office of Human Rights as set forth in Title 12, Subtitle 2 of the Howard County Code;
- (2) Look at case sourcing and the investigation process in order to make a recommendation as to whether the current process is the most efficient process that yields the most just results;
- (3) Make recommendations on how the Office of Human Rights can function as a model Civil Rights agency; and
- (4) Issue a final report to the County Executive by March 15, 2019.

AND BE IT FURTHER ORDERED, that Candace Dodson-Reed shall serve as the Chairperson of the Committee.

AND BE IT FURTHER ORDERED, that the Committee may meet as subcommittees from time to time, as needed.

**AND BE IT FURTHER ORDERED**, that the Committee shall cease to exist on June 1, 2019 and the terms of the Committee members shall expire on June 1, 2019.
