WHEREAS, to ensure that this redevelopment is coordinated and responsive to the needs of the community, I wish to create the Ellicott City Redevelopment Advisory Committee to advise the County on matters related to the potential redevelopment; and

WHEREAS, the purpose of the committee is to review the projects under the lens of each member's particular expertise and provide input on the above referenced projects; and

WHEREAS, the Committee will consist of business owners, residents, representatives of community organizations, and professionals with expertise in the field of redevelopment and historical preservation.

NOW, THEREFORE, BE IT ORDERED that the Ellicott City Project Advisory Committee is established. The Committee shall review and provide input on the projects listed above.
