- 5 (a) There shall be a Circuit Court for each County and for Baltimore City. The 6 Circuit Courts shall have and exercise, in the respective counties, and Baltimore City, all 7 the power, authority and jurisdiction, original and appellate, which the Circuit Courts of 8 the counties exercised on the effective date of these amendments, and the greater or lesser
- 9 jurisdiction hereafter prescribed by law.
- 10 (b) The judges of the Circuit Courts for **HOWARD**, Montgomery, and Harford Counties shall each, alternately and in rotation and on schedules to be established by those judges, sit as an Orphans' Court for their County, and shall have and exercise all the power,

- 16 (a) The qualified voters of the several Counties, except **HOWARD COUNTY**,

- SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read as follows:

- 14 (a) (1) (i) Instead of a direct appeal to the Court of Special Appeals under 15 § 12–501 of this subtitle, a party may appeal to the circuit court for the county from a final 16 judgment of an orphans' court.
- 17 (ii) The appeal shall be heard de novo by the circuit court.
- 18 (iii) The de novo appeal shall be treated as if it were a new proceeding 19 and as if there had never been a prior hearing or judgment by the orphans' court.

- SECTION 3. AND BE IT FURTHER ENACTED, That the General Assembly determines that the amendment to the Maryland Constitution proposed by Section 1 of this Act affects only one county and that the provisions of Article XIV, § 1 of the Maryland

1 Constitution concerning local approval of constitutional amendments apply.

SECTION 4. AND BE IT FURTHER ENACTED, That the amendment to the Maryland Constitution proposed by Section 1 of this Act shall be submitted to the qualified voters of the State at the next general election to be held in November 2022 for adoption or rejection pursuant to Article XIV of the Maryland Constitution. At that general election, the vote on the proposed amendment to the Constitution shall be by ballot, and on each ballot there shall be printed the words "For the Constitutional Amendment" and "Against the Constitutional Amendment", as now provided by law. Immediately after the election, all returns shall be made to the Governor of the vote for and against the proposed amendment, as directed by Article XIV of the Maryland Constitution, and further proceedings had in accordance with Article XIV.

SECTION 5. AND BE IT FURTHER ENACTED, That Section 2 of this Act is contingent on the passage of Section 1 of this Act, a constitutional amendment, and its ratification by the voters of the State.

SECTION 6. AND BE IT FURTHER ENACTED, That, subject to the provisions of Section 5 of this Act, Section 2 of this Act shall take effect on the proclamation of the Governor that the constitutional amendment, having received a majority of the votes cast at the general election, has been adopted by the people of Maryland.
