2 **Howard County – Sheriff – Salary**

4 FOR the purpose of altering the salary of the Sheriff of Howard County; and generally  
5 relating to the salary of the Sheriff of Howard County.

6 BY repealing and reenacting, with amendments,  
7 Article – Courts and Judicial Proceedings

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
12 That the Laws of Maryland read as follows:

13 **Article – Courts and Judicial Proceedings**

14 2–327.

15 (b) **(1)** The Sheriff of Howard County shall receive [an annual salary of]:

11                    **(II) FOR CALENDAR YEAR 2022 AND EACH SUBSEQUENT**  
12 **CALENDAR YEAR, AN ANNUAL SALARY EQUAL TO THE SALARY OF A MAJOR ON STEP**  
13 **6 OF THE HOWARD COUNTY POLICE MANAGEMENT SCHEDULE FOR THE FIRST YEAR**  
14 **OF THE SHERIFF’S TERM.**

15                    **(2) THE SALARY OF THE SHERIFF SHALL INCREASE ANNUALLY,**  
16 **ACCORDING TO THE HOWARD COUNTY POLICE MANAGEMENT SCHEDULE, FOR AS**  
17 **LONG AS THE INDIVIDUAL HOLDS THE POSITION OF SHERIFF.**

18                    SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35  
19 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary  
20 or compensation of the Sheriff of Howard County while serving in a term of office beginning  
21 before the effective date of this Act, but the provisions of this Act concerning the salary or  
22 compensation of the Sheriff of Howard County shall take effect at the beginning of the next  
23 following term of office. This limitation does not apply to an individual appointed or elected  
24 after the effective date of this Act to fill out an unexpired term.

25                    SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
26 October 1, 2022.
