#### Call to order

The meeting was called to order at 7:00pm.

### **Approve Agenda**

Angie Boyter motioned to approve the agenda. Jennifer Asher seconded the motion. Motion was approved. *All in favor. Agenda approved.* 

### **Approve Minutes**

### Office on Aging and Independence Report

- The date for the East Columbia 50+ Center celebration and groundbreaking will be December 16<sup>th</sup> at 11am. Commissioners are invited to attend.
- COA meeting dates for 2022 were given. The September 26<sup>th</sup> meeting will have to be rescheduled due to Rosh Hashanah. The October 24<sup>th</sup> meeting may also need to be rescheduled as it falls on Diwali/Deepavali. There will be no August or December meeting. In January whether to continue to meet virtually or in-person will be revisited.

## Presentation – Overview of American Rescue Plan and Howard County OAI Allocations

- March 11, 2021 the American Rescue Plan Act of 2021 was signed into law by President Biden
- \$1,434 billion were appropriated to carry out the Older Americans Act (OAA) of 1965
- Within the funding appropriated, the law allows for funding for the following areas:
  - 1) Part C of Title III (Congregate and Home Delivered Meals)
  - 2) Part B of Title III (Supportive Services)
  - 3) Part D of Title III (Evidence-based Programs)
  - 4) Part E of Title III (Caregiver Programs)
  - 5) Title VII (Long Term Care Ombudsman Program)
- Howard County received notice of the grant award on November 9, 2021 and has been allocated \$851,949. The grant awards are \$277,147 for Supportive Services, \$183,808 for Congregate Meals, \$275,711 for Home Delivered Meals, \$28,426 for Preventive Health and \$86,857 for Family Caregivers. The budget and narrative are due to MDoA January 10, 2022. The budget period is April 1, 2021 September 30, 2024.
- Title IIIB funds can be used for helping with vaccine distribution and addressing social
  isolation. Title IIIC funds can be used for congregate meals and home delivered meals such as
  Grab & Go, restaurant initiative and traditional home delivered meals. Title IIID funds can be
  used for disease prevention and health promotion programs. Title IIIE funds can be used for
  caregiver support programs. Title VII can be used for the long-term ombudsman program.
- Jenna Crawley and the Commissioners discussed how these funds can be allocated. Areas of discussion were 1) What kind of trends and needs are in the community? 2) What opportunities exist to help seed existing programs or start new ones? 3) What community partners could be worked with?

### Chair's Report

- There is no decision on the new Commissioner yet. County Executive, Calvin Ball has not communicated his decision as of yet.
- No December meeting will be held.
- Reginald Avery is finishing the letter to the County Executive. Then will send it to Jenna
   Crawley for review. Once finished he put it in letter format and send it to the County Executive.
- Reginald Avery recently received an email from Howard County that stated they were looking
  for someone to join the Long Reach Sustainable Community Work Force. They are looking for
  someone who can talk about the interests of the senior community and projects that could be
  implemented. They are not looking for someone strictly from Long Reach. If you are interested
  let him know.

### **New Business**

- Hank Greenberg, AARP State Director, was suggested as a future guest speaker when Age-Friendly goes live. He could give insights as to what is happening in other jurisdictions and states, and how Howard County could coordinate with Montgomery County.
- It was suggested that Dr. Kromm from HCGH give a presentation in the future.

The Commission expressed interest in learning more about the several assessment programs
that help County residents know about what they need to do to stay in their homes. If there is
time, it was also suggested that a panel group be created to assess what programs are
available or need to be created, and what programs are covered by insurance versus are
private pay.
