FOR the purpose of requiring that, beginning with a certain election, certain members of the Howard County Board of Education be elected by districts and certain members be elected at large; providing that a member elected to the county board from a certain geographic area but whose district boundaries are subsequently altered may remain as a member of the county board for a certain period; providing that in making an appointment to fill a vacancy on the county board the County Executive of Howard County shall endeavor to ensure that the county board reflects certain characteristics of the county population; providing for the termination of the terms of certain members of the county board; providing for the application of this Act; 13 providing for a delayed effective date; and generally relating to the election of the members of the Howard County Board of Education.
