- FOR the purpose of requiring a certain notice provided by the custodian of a public record 4 5 for the Howard County Public School System be made in writing under penalty of 6 perjury; requiring the custodian to provide written notice to an applicant regarding 7 the right to file a certain complaint with the State Public Information Act 8 Compliance Board; requiring the custodian, under certain circumstances, to petition 9 the Public Access Ombudsman concerning a request to inspect a public record; 10 providing that the custodian may deny inspection of an intra-agency letter or 11 memorandum only after a declaration by a court under certain circumstances; and 12 generally relating to the Howard County Public School System and access to public 13 information.
