"I agree that before the water connection is installed to the property, I will set a stake indicating the elevation at which the top of the meter housing or the curb stop box is to be set so as to conform to the finished grade, I further agree that after the connection is set in accordance with said elevation, I will reimburse the Department of Public Works for any expense to which it may be put for the later raising or lowering of the connection as a result of a subsequent change in the grade or failure to complete the grading as indicated by the stake." (Public, commercial & industrial only).

"If the owner or occupant(s) of the above property or properties shall violate or cause to be violated any of the above mentioned rules, regulations, and/or ordinances, the Howard County Department of Public Works reserves the right to shut off the water supply service(s) to the said property or properties until the owner or occupant(s) has (have) complied with the said rules, regulations, and/or ordinances. It is agreed and understood that every water connection installed under this application is, and shall remain, the property of the Howard County Department of Public Works, although the installation costs are paid by the applicant."

"Water connection services for which application is hereby made are to serve this particular building only and no connection will be permitted therefrom to serve any other building."

"Under certain conditions, i.e., where a property is fronted on two or more sides by water, the Department of Public Works withholds the right to indicate the location from which the said property shall be served."

Howard County Department of Public Works Rules and Regulations apply.

WATER IN AID OF CONSTRUCTION (IAC) CHARGE

The Code of Public Laws for Howard County provides for an IAC charge on water connections to cover major water facility construction (interceptors, etc.). This charge is in addition to the installation charges and applies to all property classifications including single family houses. In certain cases a supplemental IAC charge must be paid in addition to regular IAXC charge.
