# 2 Creation of a State Debt – Howard County – Ellicott City Public Arts Project

Ho. Co. 2–18

FOR the purpose of authorizing the creation of a State Debt in the amount of \$175,000, the
proceeds to be used as a grant to the Board of Directors of the Ellicott City Historic
District Partnership, Incorporated for certain development or improvement
purposes; providing for disbursement of the loan proceeds, subject to a requirement
that the grantee provide and expend a matching fund; establishing a deadline for the
encumbrance or expenditure of the loan proceeds; and providing generally for the
issuance and sale of bonds evidencing the loan.

# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That:

13 (1) The Board of Public Works may borrow money and incur indebtedness on 14 behalf of the State of Maryland through a State loan to be known as the Howard 15 County – Ellicott City Public Arts Project Loan of 2018 in the total principal amount of 16 \$175,000. This loan shall be evidenced by the issuance, sale, and delivery of State general 17 obligation bonds authorized by a resolution of the Board of Public Works and issued, sold, 18 and delivered in accordance with §§ 8–117 through 8–124 and 8–131.2 of the State Finance 19 and Procurement Article.

1 (2) The bonds to evidence this loan or installments of this loan may be sold as a 2 single issue or may be consolidated and sold as part of a single issue of bonds under § 3 8–122 of the State Finance and Procurement Article.

4 (3)The cash proceeds of the sale of the bonds shall be paid to the Treasurer and first shall be applied to the payment of the expenses of issuing, selling, and delivering the  $\mathbf{5}$ 6 bonds, unless funds for this purpose are otherwise provided, and then shall be credited on 7 the books of the Comptroller and expended, on approval by the Board of Public Works, for 8 the following public purposes, including any applicable architects' and engineers' fees: as a 9 grant to the Board of Directors of the Ellicott City Historic District Partnership, 10 Incorporated (referred to hereafter in this Act as "the grantee") for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and 11 12capital equipping of a mural for the Ellicott City Public Arts Project, located in Howard 13County.

14 (4) An annual State tax is imposed on all assessable property in the State in rate 15 and amount sufficient to pay the principal of and interest on the bonds, as and when due 16 and until paid in full. The principal shall be discharged within 15 years after the date of 17 issuance of the bonds.

18Prior to the payment of any funds under the provisions of this Act for the (5)19 purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching 20fund of \$25,000. No part of the grantee's matching fund may be provided, either directly or 21indirectly, from funds of the State, whether appropriated or unappropriated. No part of the 22fund may consist of real property, in kind contributions, or funds expended prior to the 23effective date of this Act. In case of any dispute as to the amount of the matching fund or 24what money or assets may qualify as matching funds, the Board of Public Works shall 25determine the matter and the Board's decision is final. The grantee has until June 1, 2020, 26to present evidence satisfactory to the Board of Public Works that a matching fund will be 27provided. If satisfactory evidence is presented, the Board shall certify this fact to the State 28Treasurer, and the proceeds of the loan shall be expended for the purposes provided in this 29Act.

30 (6) The proceeds of the loan must be expended or encumbered by the Board of 31 Public Works for the purposes provided in this Act no later than June 1, 2025. If any funds 32 authorized by this Act remain unexpended or unencumbered after June 1, 2025, the 33 amount of the unencumbered or unexpended authorization shall be canceled and be of no

2 unencumbered bond proceeds shall be disposed of as provided in § 8-129 of the State

3 Finance and Procurement Article.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 5 1, 2018.
