- FOR the purpose of authorizing the Comptroller to issue in Howard County a Class 5 4 brewery license to certain holders of Class B and Class BLX beer, wine, and liquor 5 6 licenses; altering in Howard County the maximum numbers of Class B and Class 7 BLX beer, wine, and liquor licenses that may be held under a certain multiple 8 alcoholic beverages licensing plan to be eligible for a Class 8 farm brewery license; 9 altering the number of Class B (on-sale) beer, wine, and liquor licenses the Board of 10 License Commissioners for Howard County may issue for separate premises to an 11 individual or for the use of a person under a certain multiple alcoholic beverages 12 licensing plan; and generally relating to alcoholic beverages licenses in Howard 13 County.

12	(b)	The Board may issue the license to the owner of a hotel that:

17		(i) at least one passenger elevator;

4 5	(i) may sell beer and wine for off-premises consumption only to persons who have purchased food or alcohol from the licensed premises; and
6 7	(ii) may not display or provide shelving for beer or wine for off-premises sales in areas of the establishment that are accessible to the public.
8 9	(4) The term of the permit is the same as that of the Class B beer, wine, and liquor license that the applicant holds.
10	(5) Before the Board may issue the permit:
11 12	(i) the applicant shall complete the form that the Board provides; and
13 14	(ii) the same advertising, posting of notice, and public hearing requirements as those for Class B licenses shall be met.
15 16 17	(6) Off—sale alcoholic beverages receipts collected under the permit shall be included in the calculation of average daily receipts from the sale of alcoholic beverages in a restaurant under § 1–101 of this article.

1	(1) \$1,000 for the Class B beer, wine, and liquor license; and
2	(2) \$500 for the off-sale beer and wine permit.

4 5	(a) (1) Subject to subsections (b) and (c) of this section, the Board may issue to an individual or for the use of a person one of the following groups of licenses but not both:
6 7 8	(i) one Class D (on– and off–sale) beer, wine, and liquor license, [two] FIVE Class B (on–sale) beer, wine, and liquor licenses, and six Class BLX (luxury restaurant)(on–sale) beer, wine, and liquor licenses; or
9 10	(ii) one Class D (on– and off–sale) beer, wine, and liquor license and eight Class BLX (luxury restaurant)(on–sale) beer, wine, and liquor licenses.
11 12	(2) The licenses specified in paragraph (1) of this subsection are for separate premises.
13 14	(b) A person may not have a direct or indirect interest in any combination of more than one Class D and nine Class B and Class BLX licenses.
15 16	(c) For purposes of this section, an indirect interest is presumed to exist between two persons if both:
17	(1) have a common parent company;
