Except as provided in paragraph (4) of this subsection and subject to 15 (3)16 the confirmation of the County Council, the County Executive of Howard County shall appoint a qualified individual to fill any vacancy for an elected member on the county board 17 18 for the remainder of that term and until a successor is appointed and qualifies. 19 **(4)** If a vacancy for an elected member occurs before the date that is 1 year 20 following the date of the member's election, the individual appointed under paragraph (3) 21of this subsection shall serve only until a successor is elected by the voters at the next 22general election. 23 (5)Candidates for the vacated office may be nominated at a primary 24election in the same manner as for any other position on the county board. 25(6)The candidate receiving the vacated position shall take office on the 26 first Monday in December after the election and shall continue to serve for the remainder 27 of the vacated term and until a successor is elected and qualifies.

- 1 (7) Except as provided in this subsection, an election to fill a vacancy on 2 the Howard County Board of Education shall be governed by §§ 8–801 through 8–806 of the 3 Election Law Article.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to the election of the members of the Howard County Board of Education for the term of office that begins on December 7, 2020.
- 7 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 8 1, 2019.
