- **I. CALL TO ORDER 6:35 P.M.** (Board Members were invited to attend *An Evening of Good Taste*, hosted by CAC, from 5-6 P.M. at the Howard County Food Bank.)
  - With a quorum present, Chairperson Harper called the June 13, 2019 meeting of the Department of Housing and Community Development Board to order at 6:35 P.M.

#### II. APPROVAL OF AGENDA

• Board Member Morris motioned to approve the June 13, 2019 Agenda as submitted. Motion passed 5-0.

#### III. INTRODUCTION OF GUESTS

• No guests were present at the board meeting.

### IV. APPROVAL OF APRIL 2019 MINUTES

• The April 2019 Minutes were e-mailed and mailed to all board members for review and comments. *Vice Chairperson Zeitler motioned to approve the minutes as submitted. Motion passed 5-0.* 

#### V. DIRECTOR'S REPORT (attached)

 Board members received a copy of the May 2019 Director's Report in advance of the meeting.

- The County Council passed the FY2020 budget on May 29<sup>th</sup>.
- Howard County's 23.6 cent fire tax increase will affect MIHU pricing & standards beginning July 1<sup>st</sup>.
- The County's fee-in-lieu rate increased from \$2.42 to \$2.65 per square foot.
- Howard County received a 2019 Achievement Award in the category of Criminal Justice & Public Safety for the Guilford Transition House.
- On May 3<sup>rd</sup>, Director Cimino attended the groundbreaking ceremony for Laurel Park Station. The mixed-use, transit-oriented development will include over 1,000 new housing units, retail and office spaces.

### VI. MIHU REPORT (attached)

- Board members received a copy of the May 2019 MIHU Report in advance of the meeting.
- During April's open-enrollment period, the Department received approximately 100 MIHU applications. 94 persons attended the MIHU homeownership information sessions and 18 persons attended the MIHU rental information session.
- The Department participated in the County's Money Matters Fair on April 28<sup>th</sup>.
- The Department met with Habitat for Humanity to discuss the possibility of partnering to help qualified, low-income candidates participate in MIHU homeownership opportunities.
- The Board discussed the fact that MIHU resales are increasing and that there is a need for regulation changes to address MIHU resale challenges.

# VII. ACTION ITEM: APPROVAL OF JULY 2019 MIHU/LIHU PRICING AND STANDARDS (attached)

- The Board reviewed the July 2019 MIHU/LIHU Pricing & Standards. Due to lower interest rates, an increase in MIHU/LIHU prices was reflected.
- Board Member Morris motioned to approve the July 2019 MIHU/LIHU Pricing & Standards as submitted. Motion passed 5-0.

# VIII. DISCUSSION AND REQUEST FOR TESTIMONY- APFO EXCEPTION FOR ROBINSON OVERLOOK

- The Board discussed the Department's request for testimony regarding an APFO exception for Robinson Overlook.
- If developed, Robinson Overlook would provide a total of 48 garden apartments, including 43 affordable rental units (of which 8 would be rented to persons with disabilities) to be leased to households earning an annual income of \$20,000 to \$61,000.
- The hearing will take place on June 17<sup>th</sup> at 7 pm. Chairperson Harper plans to testify at the hearing, and Board Member Morris plans to submit a written testimony.

# IX. DISCUSSION AND REQUEST FOR AFFORDABLE HOUSING ADVOCACY-COALITION TO END HOMELESSNESS

- Director Cimino invited the Board to attend a Summer Solstice Success
   Celebration honoring success and resilience over homelessness. The celebration,
   hosted by DCRS' Office of Community Partnerships, will take place on June 21<sup>st</sup>
   at the North Laurel Community Center.
- Board members were also encouraged to participate in opportunities to serve on committees to support the County's Plan to End Homelessness.

#### X. DISCUSSION- 2018 RENTAL HOUSING SURVEY

• The 2018 Rental Housing Survey is a detailed assessment of Howard County's rental market which determines availability, distribution and affordability of different types of rental units throughout the County.
