

Novel Coronavirus (COVID-19) Physician Guidelines for Positive Patients (rev 4-3-2020)

My patient has tested positive for COVID-19 and will be remaining at home. What information can I provide to help them?

- 3) Provide the patient, caregiver, and household members with CDC's Interim Guidance for Preventing Coronavirus Disease 2019 (COVID-19) from Spreading to Others in Homes and Communities

How can I help them limit the spread of the virus?

Please stress to your patient the importance of remaining at home and taking measures in the CDC materials to prevent the spread to others. Discuss the course of their infection and when they became symptomatic. Close contacts, starting two days before the time they became sick, are of primary concern and should be encouraged to monitor themselves.

When notified of a positive test for COVID-19 through laboratory electronic reporting, health department staff seek to contact the person who tested positive as soon as possible to interview them about their recent activities and close contacts. Depending upon their findings, the health department may reach out to those who might have had close contact with them to provide information regarding self-quarantine and monitoring of symptoms or other steps as appropriate.

It is not necessary or feasible to notify any and all individuals who may have had indirect, passing or casual contact with an infected individual. Those who become aware of an unspecific or unidentified exposure should follow all the recommended hygiene precautions and monitor themselves for signs of illness.
