- Mr. Tibbitts used "Action Network" to raise funds; he describes it as inexpensive and he had reporting issues.

- Some other options include "Act Blue" and PayPal. Use of PayPal is not encouraged as it could easily be abused.
- Some users experienced issues with counting of the contributions raised compared to the State Board of Elections.
- Candidates underestimated the amount of time it would take to raise qualifying contributions.
- Ms. Antoine offered the possibility of setting up a round table training with Montgomery County as well as reaching out to Councilman Glass to share his experience.
- The State Board of Elections will not be as involved with Howard County's Citizens' Election Fund as they were with Montgomery County's Public Election Fund.

4. Summary Guide & FAQ review:

- Montgomery County's Summary Guide & FAQ were used as a reference and updated with specifics to Howard County's code.
- The Summary Guide & FAQ were updated with the requested changes from Commission members and presented with several items that needed clarification. Each item was reviewed and updated based on the outcome of the discussion.
- Updates from the remaining items will be incorporated and sent out to the Commission member's final review by June 29, 2020.
- The State Board of Elections will review the Summary Guide & FAQ prior to it being published online. Print copies will also be made available.
