




Howard County Police Department



Serious Traffic Collision Trends



State Highway Administration (SHA) has cknowledged that these safety improvements are a high priority. Howard County is requesting that SHA program these construction funds into their capital budget.













COVID 19 Impacts




Statewide COVID-19 Budget Impacts

- MDOT's 6-year CTP for FY2021-2026. shows a \$2.9 billion reduction over the last 6-year plan.
- MTA FY21-26 capital budget reduced by \$150m.
- MTA FY21 operating budget reduced by \$70m.
- Highway reductions represent approximately 50 percent of total reduction
- Cuts to system preservation budgets for has a long term fiscal impact
- Only hope for immediate infusion of funding would be through federal legislation.


MDOT-wide Operating Reductions

- MTA #150 Express Bus suspended from Columbia to Harbor East via Ellicott City
 - Five trips per day in each direction
 - Only reverse commute options (2 trips) from Baltimore City
- MARC Service operating at 60% (R Schedule) of normal levels. Ridership at 10-13% of 2019 levels
- Commuter Bus Operating at 45% on most routes. There are 8 routes in Howard County. Route 320 to Baltimore is maintained. Ridership is at 10-15% of 2019 levels
- Local RTA Service operating at 60%.
- Federal CARES Act transit funding will replace 20%
 reduction in state funding and lost fare revenue in FY 20 –
 FY 23. (More to follow)



Regional and Long Range Planning COVID-19 Impacts

Bike and Pedestrian Update

- Adoption of WalkHoward, Howard County's Pedestrian Master Plan, 2020
- Implementation of several infrastructure recommendations from BikeHoward and WalkHoward Plans
- Initiation of a permit process for shared electric scooters (1- year trial to start in Spring 2021)
- Legislation prohibiting parking in bike lanes (CB49-2020)





North Laurel Connections

- Howard County awarded a Kim Lamphier
 Bikeways Network Program grant from Maryland
 Department of Transportation
- Over \$500,000 in grant funds to assist in constructing 5.6-mile bicycle and pedestrian route between Savage and Laurel, connecting parks, trails, community center, and 2 MARC stations
- Part of Howard County's Bicycle Master Plan,
 BikeHoward

 - Smaller footprint






- Real-time Bus Arrival Information-Fall 2020
 - See nearby routes based on your location
 - Track real-time vehicle locations
 - Displays the next 3 departure times
 - Trip planner
 - Receive service alerts
- Mobile Ticketing-2021
 - Make the buying and paying of a transit fare more convenient
 - Removes the need to carry cash
 - Can purchase tickets online for others
 - Allows for fare capping
- Automated Bus Stop Annunciators 2022
 - Provides a visual and audible announcement of approaching bus stops
 - Improves access for riders with visual and hearing impairments

Roadway System

1,074 centerline miles of roadway

Approximately 3,600 County owned and maintained roadways

Infrastructure in the Public Right of Way

- 900 miles of sidewalk
- 300,000 street trees
- 31,000 street signs
- 100 traffic signals
- 7,950 street lights


Funding

Highway Preservation System

- All roads inspected once every 2 years (1,074 miles)
- Average life of 15 years before repairs needed
- Based on mileage and life expectancy, need to repair about 71.6 miles each year
- It costs \$200K/mile, so we need \$14.3M per year
- Currently ten-year average funding is \$5.6M/year







- Phase II Upgrade few neighborhoods
- • Installed 221 new LED streetlights
- Phase III Upgrade at traffic signals, roundabouts and midblock crosswalks - Ongoing
- •Phase IV Rest of the County FY21/FY22 completion







2020 Resurfacing Projects

- 39.15 lane miles of resurfacing
- 8773 tons of patching
- 12.52 centerline miles of microsurfacing
- 3.83 centerline miles of cracksealing
